The Conscientious Objection (Medical Activities) Bill seeks to clarify the extent to which a medical practitioner with a conscientious objection may refrain from participating in certain medical activities, namely withdrawal of life-sustaining treatment and activities under the Human Fertilisation and Embryology Act 1990 and the Abortion Act 1967. Statutory exemptions for conscientious objection already exist for two of the medical activities the Bill aims to cover.
