The Report of the TPRB from the Director-General on Trade-Related Developments shows WTO members applied 38 new trade restrictive measures worth a total cost of US\$339.5 billion between mid-October 2018 and mid-October 2019—44 percent above 2012 levels when the reports were first introduced. It follows an increasingly destabilising period, when between mid-October 2017 and mid-October 2018, restrictive trade measures reached a record high of US\$588.3 billion.

The review of the dispute settlement system of the WTO was written into the results of the Uruguay Round establishing the organization. The planned review after four years failed to reach a conclusion and the review process was extended several times, to be finally taken up as a separate part of the Doha Round.
